You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Foreign Exchange Instrument

Term

The maturity of this product is in 12 months. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of the product is to give the investor the right and obligation to the outcome of the structure according to terms agreed in advance. An importer buying a booster forward has the opportunity to convert at an attractive exchange rate. The investor will participate in any price development in the underlying. In other words, the investor will profit if the currency being bought strengthens against the currency being sold, or lose in the event of an opposite development.

The product involves the following cash flows:

The notional amount will be distributed among the number of expiration dates. For each expiration date (one or more) on which the exchange rate trades above the bonus rate, the customer will exchange the single notional amount at the bonus rate. If the exchange rate trades below the bonus rate at expiry of a period, the customer will exchange the notional amount, multiplied by the ratio, at the bonus rate.
