Purpose

This document provides you with key information about this product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to enter into a product that is not simple and may be difficult to understand.

What is this product?

Type

This product is an over the counter (OTC) contract – Interest Rate Instrument

Term

The maturity of this product is in 5 years. No party is entitled to terminate it unilaterally. Therefore, early termination of the contract is not possible.

Objectives

The purpose of this product is to hedge an underlying interest rate exposure by periodically exchanging variable for fixed interest rate payments from the start date until the end date.

A Payer Swap with Floor is a binding agreement to exchange interest payments based on a pre-agreed amount (notional amount) on future dates (Interest Rate Payment Dates) that are agreed when entering into the trade. The interest payments are defined as one party paying a fixed interest rate agreed when the interest rate swap is entered into while the other party is paying a variable interest rate (STIBOR). The variable interest rate cannot be lower than the Floor Strike, usually at 0%.

The cash flows of the product are as follows:

By entering into this Payer Swap with Floor, you will receive interest payments equivalent to STIBOR from DNB on the Interest Payment Dates, provided that the STIBOR cannot be lower than the Floor Strike, normally set at 0%. In return, you will pay DNB fixed rate interest payments on the Interest Payment Dates.

The risk indicator assumes you keep the product until the agreed maturity date. You may not be able to end your product early. You may have to pay significant extra costs to end your product early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of DNB Bank ASA

to pay you. In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may be significant. This product does not include any protection from future market performance so you could incur significant losses. If we are not able to pay you what is owed, you could incur significant losses.

Recommended Holding Period: 5 years
